INTERNAL REVENUE SERVICE (IRS)

Authority: established by act of July 1, 1862 (26 USC 7802) as the Office of the Commissioner of Internal Revenue.

Responsibility: administer and enforce the internal revenue laws and related statutes, except those relating to alcohol, tobacco, firearms, and explosives. Its mission is to collect the proper amount of tax revenue at the least cost to the public, and in a manner that warrants the highest degree of public confidence in the Service's integrity, efficiency, and fairness. To achieve that purpose, the Service will encourage and achieve the highest possible degree of voluntary compliance in accordance with the tax laws and regulations; advise the public of their rights and responsibilities; determine the extent of compliance and the causes of noncompliance; properly administer and enforce the tax laws; and continually search for and implement new, more efficient ways of accomplishing its mission. Basic activities include: ensuring satisfactory resolution of taxpayer complaints, providing taxpayer service and education; determining, assessing, and collecting internal revenue taxes; determining pension plan qualifications and exempt organization status; and preparing and issuing rulings and regulations to supplement the provisions of the Internal Revenue Code.
