- 1. The CP 186 Notice generates when:
 - A. A payment transaction posts to a module and the credit amount is greater than the assessed module balance due amount, and
 - B. There is an interest or penalty computation restriction present.
 - C. It also generates when an account is transferred in from the Retention Register with Doc Code 51 or 52.

 - D. Recompute the interest or penalty using CC COMPA or COMPAF per IRM 20.2, on the remaining CP 86/186.
 - E. If additional interest or penalty is due, input an adjustment transaction to assess the additional amount using CC REQ54. Caution should be taken when there is a 120% interest charge on the account. The interest TC will have a Julian date of 999.
 - F. If no additional interest or penalty is due, input TC 290 for a zero amount with blocking series 15 and Hold Code (HC) 3 using CC REQ54. Use blocking series 00 if you have the original return. Use the CP 186 as your source document.

Residual Transfer Records (F2 Record) — A residual transfer record is created when a data base is transferred to another service center. It remains on the data base for 30 days after a data base has been transferred to another center.

Retention Register — A microfilm tape of accounts removed from Master File due to inactivity in the account. The Master File has a limited capacity, thus accounts that are unlikely to be needed again are removed to a less accessible file. The basic criteria for removal of a module to the Retention Register are a zero tax balance, no freeze or unsettled conditions present and no activity for 27 months. Transactions cannot post to the Retention Register therefore, if the account is to be put on AIMS, the module must be brought back to Master File. Check IMFOL/BMFOL to see if CC IMFOLB/BMFOLB (not until 1998 at the earliest) can be used to bring account back to active Master File status. See Retention Register Reinstatement Procedures Exhibit for instructions on bringing accounts back from retention.

Retention Register Indicator (RETN-REG-IND) -- Set when a TC 424 rejects due to the account being on retention. 28 days from the opening creation date, it causes the TC 424 to automatically regenerate every two weeks until the case is 3 months old, hoping that the account is being brought back from retention. See Retention Register Reinstatement Procedures Exhibit. If the account still has not been brought back from retention after 3 months, a weekly update report record with condition code 24 will be generated and the record will be aged off of the AIMS data base. (P1-L8/Exhibit 4.4.1-24)

Return Posting Year (RET-PSTNG-YR) -- The year a return originally posted to Master File. (P1-L16)

Return Requisition Indicator -- Indicates whether the return, charge-out and labels were requested when the AM424/AMSTU was input. (P1-L14)

Return Received Date (RET-RCVD-DT) -- For timely filed returns it is the due date of the return. Example: Form 1040 due April 15 will be displayed as April 15 of the appropriate year even if the return was filed before the due date. For late filed returns it is the received date stamped on the return. For SFR cases it is the date the examiner entered on the SFR 1040. (P1-L16)

Revenue Base Protection -- If a taxpayer files a claim for refund, Examination gets credit on the Exam tables by entering the amount of the claim, the time spent on the claims and the type of claim. See the Revenue Base Protection section in the Examined Closing Chapter.

Self-Employment Tax Rates -- See Document 6209

Service Center Codes -- See Exhibit 4.4.1-17

Short Closing - An AIMS closing of a non-examined return (other than a survey of a claim) via CC AMSOC. See Non-examined Closings Chapter.

Skeletal Accounts (F1 Records) – AIMS creates a skeletal record when a CC AM424 is input, showing the requisition and limited taxpayer information. Once the request goes to Master File and is matched, Master File sends an opening record to AIMS and the account becomes fully established. Once fully established, AIMS sends a TC 420 back to Master File. Only the organization

The next page will shows a good item we will FOIA called a IMFOL as a cross check for transactions moved incorrectly from the Master File (MF) to the Retention Register.

The following three pages show TC 370 is the code the IRS uses to move transactions from your Retention File back to your IMF.

8.17.3.1.3 (04-12-2001)

Requesting Transcripts through Microfilm Replacement System (MRS)

- 1. MRS is an automated research system which replaced the microfilm research done in the Service Center and District Offices many years ago. However, three types of microfilm continue to be researched in the microfilm units:
 - A. Current Microfilm -- These microfilms contain data, which cannot be found by using MRS. They are updated periodically and include the Partnership Name Directory, EPMF National Alpha Register, 1042S Index Register, CAWR Module Register, and the Federal Tax Deposit Registers.
 - B. Retention Register -- These microfilms contain modules, which are no longer carried on the Individual Master File (IMF) and the Business Master File (BMF). The Retention Registers require index information to be accessed. This information is found on the Reference Registers for prior to cycle 198401 located in the Microfilm Unit or in the retention register data section of certain types of MRS transcripts. The first IMF Retention Register was produced in January 1969. The first BMF Retention Register was produced one year later.
 - C. Archival Microfilm -- These microfilms contain information that predate MRS.
- 2. Research of all IMF and BMF accounts is accomplished through the Integrated Data Retrieval System (IDRS). IDRS is a system that enables employees in the Service Centers and the District Offices to have instantaneous visual access to certain taxpayer accounts.
- 3. If access to IDRS is available, Tax Computation Specialists may directly input transcript requests on IDRS.
- 4. If the transcript request is not directly input, a completed Form 6882, IDRS/Master File Information Request, can be forwarded to your Records Section for input via IDRS.
- 5. Document 6209, ADP and IDRS Information, is updated annually and provides detailed information on command codes used in generating transcripts.

8.17.3.1.4 (04-12-2001)

Types of Transcripts Available on Master File

- 1. The following command codes generate various types of Master File transcripts available through IDRS:
 - A. TXMOD -- This transcript contains more detailed and more current account information than any other single command code. TXMOD information is only available when there is current activity on an account.

Item FOIA requesting

- B. IMFOL -- This transcript will provide read-only access to the Individual Master File (IMF). It also provides a listing of the modules removed to the retention register. Tax Computation Specialists usually use command code IMFOL with definers R and T. IMFOL should be used in lieu of MFTRA where possible.
- C. BMFOL -- This transcript will provide research of nationwide entity and tax data information posted to the Business Master File (BMF). It also allows research of modules dropped to retention in

3.5.61.4.2.1 (01-01-2002)

Background

- 1. A taxpayer will initiate a complaint or petition in a suit for recovery of taxes. This will be forwarded to the appropriate service center by a United States Attorney in district court cases, or by the Tax Division of the Department of Justice in Court of Claims cases.
- 2. In order to assist the Service in expediting retrieval of the necessary files, telephonic contact (followed up via memorandum) will be made by the offices indicated above. These calls will provide pertinent information on the taxpayer and tax liability in suit.
- 3. Facsimiles (FAXs) and memorandums have been coming from District Counsel, as well as Chief Counsel, since July 2, 1978.
- 4. The instructions contained in this subsection will refer to "Counsel" meaning either District Counsel or Chief Counsel.
- 5. It is expected that the telephone call and copy of the complaint or petition will be received prior to the FAX or memo from Counsel requesting the files. The information requested will be sent to the office requesting it, whether it be District Counsel or Chief Counsel. This information must be sent using either certified or registered mail.

3.5.61.4.2.2 (01-01-2002)

Processing Request

- 1. Maintain a monthly log, showing all new case requests processed during the month and the dates on which the telephone call, initial complaint and the FAX/Memo received.
- 2. Take the following action immediately upon receipt of the taxpayer's complaint, telephone call or FAX/Memo:
 - A. Use command code ACTON to establish an open control base for all affected tax modules.
 - B. Each tax period involved in a refund suit must be identified with a TC 520 freeze with CC73. If a TC 520 with CC73 is not present, it must be input.
 - C. If the account has been moved to the retention register, use applicable procedures to reestablish the account (TC370).
- 3. Research and secure the requested document(s) using expedite measures.
 - A. When documents are found to be charged-out, contact the necessary activity to immediately obtain the required documents. This must be done regardless of where the documents are charged-out.

- 3. IRS No. Sequence Posting On The Tax Module:
 - A. IRS Numbers appear in the sequence they were input on ISRP.

The next four pages show that a TC 370 transaction can have Doc Code 51 or 52 associated with it.

 - C. Do not make any adjustments on Form 706 accounts with installment privileges (Status 14). Forward to the Accounting function for action.
 - D. Recompute the interest or penalty using CC COMPA or COMPAF per IRM 20.2, on the remaining CP 86/186.
 - E. If additional interest or penalty is due, input an adjustment transaction to assess the additional amount using CC REQ54. Caution should be taken when there is a 120% interest charge on the account. The interest TC will have a Julian date of 999.
 - F. If no additional interest or penalty is due, input TC 290 for a zero amount with blocking series 15 and Hold Code (HC) 3 using CC REQ54. Use blocking series 00 if you have the original return. Use the CP 186 as your source document.

The fourth page down says Substitute for Returns (SFR) and manual returns reestablished from the Retention Register are not corrected. Well this is how they can "lie" to the computer system to create your phony tax liability.

I have one tax year where my IMF shows four (4) TC 370 entries within a matter of several months.

 - B. The TC 370 does not appear on the transfer document, but is generated as part of the program with the transfer-in amount. The TC 370 must be entered on Form 813.
- 2. Accounts may be transferred into the master file on either Form 3413.

Transcription List, or Form 3552, Prompt Assessment Billing Assembly.

- A. Forms 3552 are prepared and routed to ISRP for input to the master file. Forms 3552 represent new assessments. See IRM 3.17.24.3.
- B. Forms 3413 are prepared by the transfer function and represent previously-made assessments. The requestor should be identified on the request for a transfer so that unprocessable transfers may be returned to the originator.
- C. Reactivations from the Retention Register are covered in detail in section. These are numbered with document code 52.
- D. Other account transfers on Form 3413 include true NMF accounts. MFT 31 IMF transfers, retransfers, and manual assessments. These are numbered with document code 51.
- 3. All account transfers-in must contain either a debit or a zero balance. If the account is in credit balance, contact the requestor for resolution. A debit must be added before the transfer can be processed.
 - A. Contact the requestor to verify that the credit is valid. If the credit is not valid, return to the originator for resolution.
 - B. If the credit balance is valid, the originator should transfer the excess credit on Form 2424 (or DRT 24) or Form 3809 (or DRT 48) to the new module. Then transfer the account after the balance has been reduced to zero.
- 4. Do not enter any amount of over \$99,999,999.99. The master file limits each amount field to fewer than 11 positions.
 - A. Form 3413 may be corrected by splitting any amount other than the Transfer-In amount and creating one or more new transactions.
 - B. If the Original Assessment Transaction Amount is too large, split the amount and enter the balance in the first available field(s) in sections 02-19, using TC 290 in place of TC 150.
 - C. If the Transfer-In Amount is too large, prepare an additional Form 3413 and split the transactions so that the amounts will not be over \$99,999,999.99.

Account Retransfers

- 1. The following types of cases require retransfer action:

Use of Form 5598, EO Correction Request

- 1. Form 5598 is limited at group level. The only common uses for groups are to change source codes and activity codes. Corrections can be made as long as the account(s) are on AIMS. Generally, an account is available for ninety days after it has closed. If the correction is to a record that has aged off of AIMS, a correction cannot be done. Instructions for preparing Form 5598 are in Exhibit 2-28.
- Corrections must be made at the time that the error is discovered.
 Responsibility for making corrections falls to the EO function (Group, RPM, Review Staff, etc.) handling the account at the time the error is discovered. A maximum of twenty accounts can be corrected using the same Form 5598, if the identical corrections are being made to each of the accounts.
- 3. Use Form 5598 whenever:
 - A. An error is found on an AIMS--generated output such as a Form 5546, Examination Charge-Out, a label, a CC AMDIS/AMDISA print, etc.
 - B. An error is discovered during quality review of a document previously used as terminal input to AIMS
 - C. An error is recorded on the Service Center or Detroit Computing Center error registers.
- 4. Completed forms are routed to the approving official who reviews the forms to ensure the quality and integrity of the requested action. The approving official will return an unapproved Form 5598 to the requester with a statement indicating the action that should be taken in lieu of that recorded on the correction request. The Group Manager of the initiator approves district Form 5598 requests to correct items.
- 5. A correction to a closed record, Status 8X or 90, causes the Report Extraction Indicator to be reset. If the record passes all the consistency and validity checks, the corrected record will be extracted during the next report extraction period and the EO tables for the Key District Office will be updated with the correct information. If the correction is to a record that was closed to an Appeals Office that is outside the jurisdiction of the Key District Office's service center, the AIMS data base must be backed-down to EO in the closing Key District Office in order to input a correction.
- 6. Disposition of Form 5598 -- Retain Form 5598 sixty days after returned from EP/EO-SP. Form 5598 should then be disposed of according to Records Control Schedule 203 (formerly IRM 1(15)59.23).

[7.3.1] 2.41.4.3 (04-30-1999) Correcting Activity Codes

1. Activity codes should be entered on all requests for returns. When the activity code is not known, it should be estimated. If the estimated activity code of an EPMF or BMF requisitioned return is wrong, it is corrected automatically and the AIMS data base will reflect the true activity code.
