


#### CHART ONE

Ever since the 1950's, there has been a steady decline in the rate of marriage (the decline from 1920 to the 1930's may be explained away by both economic and first wave feminism, plus World War I concerns).. However; from 1950's onwards, we see the implementation of the new Feminized socialist order promulgated by government replacement and overt attack of fatherhood.

Again, we see the three separate phases we are concerned with here. PHASE ONE—where from 1955-57 onwards, the implementation and growth of the Single Female Headed Household, (SFHH) exploded, and received government support.










**Chart 21**

Again, children subjected to the miracle of the Krell Welfare Machine, become: (According to a new publication called Getting Men Involved: The Newsletter of the Bay Area Male Involvement Network), Spring 1997:

- 63%** of youth suicides are from fatherless homes (Source: U.S. D.H.H.S., Bureau of the Census)
  - 90%** of all homeless and runaway children are from fatherless homes
  - 85%** of all children that exhibit behavioral disorders come from fatherless homes (Source: Center for Disease Control)
  - 80%** of rapists motivated with displaced anger come from fatherless homes (Source: Crim. Justice & Behavior, Vol 14, p. 403-26, 1978.)
  - 71%** of all high school dropouts come from fatherless homes (Source: Nat. Principals Association Report on the State of High Schools.)
  - 75%** of all adolescent patients in chemical abuse centers come from fatherless homes (Source: Rainbows for all God's Children.)
  - 70%** of juveniles in state-operated institutions come from fatherless homes (Source: U.S. Dept. of Justice, Special Report, Sept 1988)
  - 85%** of all youths sitting in prisons grew up in a fatherless home (Source: Fulton Co. Georgia jail pop., Texas Dept. of Corrections 1992)
- (Because only a portion of each age group grew up in a fatherless home,) these statistics translate to mean that children from fatherless homes are:

- 5** times more likely to commit suicide
- 32** times more likely to run away
- 20** times more likely to have behavioral disorders
- 14** times more likely to commit rape
- 9** times more likely to drop out of high school
- 10** times more likely to abuse chemical substances
- 9** times more likely to end up in a state-operated institution
- 20** times more likely to end up in prison.



This dependable anarchy and impressed and engineered social pathology all sustained and developed by the governmental infrastructure has created itself: the Krell Welfare Machine:




This is the inner workings of the KRELL WELFARE MACHINE established and propagated by government and untold special interests. This is what is not only killing this society, destroying fathers, ripping apart children and cannibalizing our own children. This is the “Machine” silently and surreptitiously stealing from each and every American. If you notice, in the upper left hand corner of the chart, you see the major SFHH arrow pointing upwards. These are known as “Railroad Tracks” in Washington D.C., as they are all interdependant curves. When the SFHH goes up or down—so do these also, **as they are directly functional and correlative values implicitly tied the the success or failure of the SFHH.** Government knows this, and through a corrupt Judiciary, closely sustains and protects the SFHH entity. As you can see from the small lines with arrows extending from the SFHH, (support lines) each entity within the Krell Machine supports the other related values within the system. Those of course support government, which in turn empowers (through the Legislative Branch) the National Debt, which then instantly goes and funds the SFHH...and the closed cycle continues.






Oddly, (this was never the intent when I first developed this chart, but by accident it fell on the floor and I instantly recognized the model) when you turn the Krell Welfare Machine upside down, you get our American form of government. Here you see sexual regulation at work. You see Fatherhood held in high esteem, you see marriage, family, stability, eugenics all working towards a regulated society. As Freud, Plutarch and other great thinkers all noted “In order to have an advanced society, you need sexual regulation.” This is the advanced society model, with individual savings, free enterprise and the rule of law supporting it, both regulating society and advancing it. With this model it is impossible to have a Krell Welfare Machine (Socialist/Communist) form of government. It was Marx himself who recognized this, as he knew that no society could be both socialist and capitalist. This is why the inverse of the Krell Machine, turns out to be our American form of government. Simply put, this nation will either be a Patriarchal nation, or it will be Matriarchal. (Matriarchal closely delineated to Socialist Marxist forms of government and Patriarchy intimately aligned to Capitalist and Free Enterprise forms of government. Again, quoting from Milton Freedman, in his book *Capitalism and Freedom*, he notes this when he admonishes those “[whose] idea is the advocacy of ‘Democratic Socialism’” which he concludes “[that] only certain combinations of political and economic arrangements are possible, that in particular, a society that is socialist **cannot** be democratic.”[Chapter 1, pg. 32]

This nation will either be a Patriarchal one, or a Matriarchal one—the two, like matter cannot be combined. Marx knew this, and those students of Marx will note, one of the first things he did was to “free” women from marriage. The Bolshevik revolution itself was predicated on allowing women to enter the workforce. 



It has created a huge empire of courts and prisons:




This is a grave indicator that we are being destroyed and overthrown by and from a domestic enemy from within.



As wages go down for the populace:





Who are entering these ever exploding prison rates??

Men. Hundreds of thousands of innocent men, whom are merely “invented” into criminals, only by a stroke of a pen.

For instance, this is how the Krell Machine works:

Establish a superstructure that allows the female to dream upon any instance—any “abuse” or “reason” she needs to cash in the marriage or relationship. Once that is done, upon her mere “dream” the Krell Machine will initiate.

From that you charge and enforce false charges upon any instance, and fault the male. 



### Estimated Surgical Abortions in the U.S. by Marital Status, 1972–1997



### Problem Behaviors of Children by Parents' Marital Status



### Family Structure for Children Aged 14 to 18



### Impact of Divorce on Income of Families with Children








**Average Grade Point Average For American Teenagers By Family Background**






Chart 19

**Teen Feels Close to Dad: Virginity Rates**





**Loss of Virginity, Peers, and Teenager's Own Worship**



**Young Adult Males: Virginity and Church Attendance**







Yet still the Krell Machine stays on:




